This is a formal demand Kenneth Lay of Crowley Fleck immediately cease and desist from contacting and harassing other parties regarding us, our contact information, or our property. Our contact number and address have not changed. We have no other information to provide to you.

No forceful entry into our property or removal of our personal belongings during the 2022 National Day of Prayer was warranted, justified, lawful or ethical. No notice, letter, request, demand, or other communication was received from HSBC prior to the unexpected and unlawful invasion of our ranch, exposure of our family and property to unknown security and health risks, and malicious hate crimes being committed against us. This flagrant and unconstitutional violation of our safety, security, and privacy combined with the complete disregard for codified, regulatory, Constitutional, and inalienable protections has created extreme risk and damages that are accruing exponentially with blocked opportunity for relief.

These draconian acts occurred when court documents and significant evidence of moving efforts at the ranch demonstrate we proceeded with removing our personal property from our lawfully owned ranch in the middle of a pandemic, during historic supply line shortages, with widespread relocations catastrophically depleting housing and moving resources, threats of world war, record setting fuel costs, weather complications (over 29 inches of snow on our ranch the week of Easter alone), and with national eviction moratoriums in place. These acts of good faith by our family occurred when any alleged need to move is reliant on erred and fraudulently obtained judgements, when the statutory extension of our redemption timeline has not lawfully expired due to HSBC's refusal to obey the law, and this entire foreclosure should never have happened per Montana and United States law.

Therefore, any and all delay, inconvenience, expense, liability, and exposure you are or may experience was and is comprehensively caused and precipitated by the unlawful actions of HSBC, your office, the Lewis and Clark County Sheriff's Office, and other known and unknown accomplices. Any damage or harm which comes to our persons, personal possessions, animals, and agricultural operations will only increase the

We have and will continue to fight to expose the acute regulatory failure, systemic corruption, and judicial tyranny that is threatening our property rights. Please exercise your ethical responsibilities in informing any interested or vested parties we are the only true and lawful owners of [REDACTED] and we are wholly committed to actively seek Constitutional redress in this matter.
