We would like to begin by thanking you and your team for your service to Lewis and Clark County. Your statements regarding the importance of upholding the Constitution and verbalized desire to ensure all members of your office do the same are appreciated. On a personal note, we have appreciated and respected your willingness to be branded as a Christian Sheriff through the years as exhibited by your attendance and participation at the National Day of Prayer, Governor's Prayer Breakfast, local prayer meetings, and other Christian gatherings. Thank you. If more officials would unashamedly stand for their beliefs and publicly live out and display their convictions, the morality and stability of our country would be greatly benefited. Please know we continue to pray for you, Montana, and all those who lead and protect our great state every day at 4:06 and our country at 2:02. We pray God will grant each of you individually and corporately the wisdom, courage, character, and strength to stand for the truth, do what is right, and not grow weary or derelict in your duties to faithfully and effectively protect and preserve our American homeland.

Our previous experience and relationship with you, and others who have attested to your character, compel us to write this letter to summon the oversight of your integrity regarding the attached information request. All information being sought is public record. However, Deputy Clint Pullman has previously blocked our requests for copies and to view the file on our family and property. Although Deputy Clint Pullman did agree to provide us with one letter of instruction, it was not the specific letter we asked for. When we tried to obtain the correct letter, he became curt and stated we did not need it. Quite frankly, not only is denying a pubic record's request an overreach of his authority and a Constitutional blight on the way your office is being run, but stating and behaving as if it is his intention to conceal matters of public record is official misconduct and criminal in nature. Your intervention in securing a complete copy of our file is requested.

Additionally, numerous times at and during the sale(s)of our Montana Ranch, Deputy Clint Pullman referred to your office as the "sheriff's department." This was very surprising and alarming to us knowing your verbalized strong feelings and stand on this issue, and his position of authority and longevity in your office. So much so, his wording led us to include the word "department" in our records request to ensure we had included all applicable divisions of your office and there is not a secret "department" holding our records, or that he could relocate our records to, that we have not specified or addressed.

Another matter of concern is Deputy Clint Pullman brought multiple armed uniformed and plain clothes officers to the sale who appeared to have been issued a directive to ensure someone followed our family at all times.
